Group Grant Program

(excludes 501 (C) 3 non-profit)

Brunswick Arts Council provides a Group Grant Program in all art disciplines to groups whose programs contribute to the arts and culture of Brunswick County.

Funds have been set aside to be offered to groups which includes clubs, associations and similar affiliations providing artistic and/or cultural offerings or services, such as forums, lecture presentations, school programs, seminars, reading programs, photography, music, ceramics, poetry, wood turning, and other similar activities that provide high quality art programs benefiting the Brunswick County community.

Grant awards of \$200 to \$2,500 will be considered.

The Following Categories Will Be Evaluated For Group Grant:

- Groups whose mission focuses solely on the arts.
- Groups who are looking to improve the performance in a specific area of the arts.
- Groups who provide education and/or appreciation of the arts.
- Groups must comply with all local, state, and federal laws as well as all funding requirements detailed in the application.



Group Grant Program

*The Following Are **Not** Eligible For The Group Grant*

- Organizations/groups who are incorporated as a 501(C) 3 Non-profit
- Organizations who have received a Brunswick Arts Council Grassroots Grant.
- Businesses for profit.
- Individuals.
- Private organizations with a primary focus toward historical preservation, public broadcasting media, church or church affiliated programs, government institutions.
- Any organization in existence less than one year.

IMPORTANT ITEMS TO BE INCLUDED

1. A short narrative of your organization and its involvement in the community.
2. Documentation (if available) can be included of past programs and events.
3. Brochures and marketing materials may be included.
4. Be sure to state if your programs attract a diversified audience participation.

Incomplete or late applications will not be considered.
